The TDAA held their Annual Meeting May 4-6, 2023 in conjunction with the TDA meeting in San Antonio, Texas. As a fellow member of TDAA, we are excited to update you on the changes we made to our TDAA ByLaws.

We created new opportunities by focusing on inclusiveness, adaptability and a stronger emphasis on the individual member with these changes. In fact, the ADAA made these same changes to their ByLaws on February 20th, 2022. We are now in alignment with our national organizations ByLaws.

We will still be using Robert's Rules of Order to conduct our organizational business, but now we will spend less time on governance, and more time on building revenue and programs for Dental Assistants. These changes promote inclusiveness and create opportunities for individuals to become involved more easily and quickly.

The biggest change was removing the House of Delegates format to a General Assembly format. What this does is allow any member to be a voting member at our Annual Session meeting. In a nutshell, if you are a TDAA member, then you can come to the Annual Session and vote. Our previous format was a House of Delegates format which only allowed up to 3 people to represent a local organization in Texas and up to 3 people to vote if you were from a rural community that did not have a local organization near you. Everyone is welcome and now has a voice on what TDAA is focused on accomplishing.

The elected officers shall remain the same that includes President, President-Elect, Vice-President, Secretary and 5 Directors. As a voting member you will be voting on the General Election for these positions stated above, passing a budget for where we want to spend our money and be involved in voicing where or how we should focus our efforts. We believe that more members will feel as if they are contributing and therefore be more invested in the TDAA.

Local organizations or study clubs can still be organized in a town, city, county, or district for the purpose of furthering the objectives of this Association. In fact, at the meeting a group of educators are looking to reactivate a local in the Corpus Christi area very soon. The TDAA officers want to hear your thoughts, your concerns, your ideas and move forward to help all dental assistants in Texas. For example: we created a Facebook page several years ago and help out of state dental assistants weed through the process of obtaining their Texas RDA.

In conclusion, we are opening our doors wider and allowing any and all members to have a voice to help TDAA succeed as a state chapter of the American Dental Assistants Association. Our objectives are the same:

To advance the careers of dental assistants and to advocate for the dental assisting profession in matters of education, professional activities, credentialing, and legislation. To promote the ideals and growth of the Association which aid in the accessibility and delivery of quality oral health care to the public.



WARNING MAILING PAPER CHECKS IS RISKY

Mailing paper checks is risky, now more than ever. They are not a secure form of payment anymore. In fact, according to security experts, it might be the least secure payment method for exchanging money and completing transactions.

The reasons are numerous, and criminals are finding ways to create fake checks, alter checks with household chemicals (check washing), or stealing a victims identity by mail theft.

There is a lot of information a thief can obtain by your check. Your name, address, phone number, your bank's name, address and your bank account number, routing number and your signature. Businesses who accept checks might also ask for your driver license number and date of birth too. These are all key components for identity theft. Criminals have been increasingly targeting mailboxes to commit check fraud. In fact, the USPS is now recommending that you take your mail that includes a check directly to the post office and not leave it in your mailbox or drop it off at one of the blue postal collection boxes.

In an effort to keep our national association safe from this type of criminal activity, the ADAA has had to reevaluate how they receive and disperse funds (such as rebate checks to states).

Last year, reports of check fraud filed by banks nearly doubled to 680,000, from 350,000 in 2021 according to an article published in the New York Times on January 5, 2022. It's a big deal right now and it's getting worse. There is a reason why government issued funds are done by direct deposit; it is a safe, secure, efficient, and less expensive than paper check payments and collections.

The purpose of why this information is being brought to every TDAA members attention is to notify you to pay your ADAA membership with another form of payment than a check in the mail. ADAA accepts credit card payments on their website which is totally secure. Do not take the risk of having your check stolen and used by a criminal who could empty your checking account or steal your identity.
